A: There seems to be a bug in 64-bit for version 1.56. I was able to get the 64-bit version to install and run with no problems. I also get a "stardock.exe" error when running the program, but I don't know why. I will update my answer once I get a chance to study the errors. On a side note, just what can you do to stop this dead in it's tracks? or one of the equivalent forms of both, or be interpreted in such a way as to be harmful to a person's rights, seriously impugning a person's integrity or reputation or bringing a person into disrepute; or be calculated to deceive or mislead any person. In order to obtain relief on a claim of factual insufficiency, appellant must show that the proof of guilt, though legally sufficient, is nevertheless so weak as to render the conviction clearly wrong and unjust or that the verdict is against the great weight and preponderance of the

evidence. *Watson*, 204 S.W.3d at 417. In conducting a review for factual sufficiency, we review the evidence weighed by the jury that tends to prove the existence of the elemental fact in dispute. However, we must also appropriately reduce the weight to be given testimony that conflicts with the State's evidence. *Id.* at 417-18. A factual sufficiency review of a conviction necessarily requires a review of the credibility of the evidence by the fact finder. See *id.* at 417. We do not substitute our judgment for that of the fact finder. *Id.* at 416-17. A factual sufficiency review requires a review of all the evidence. *Id.* 2d92ce491b
