Photoshop is a commercial product, so it is not available to all computer users. However, there are a number of free and open source software packages based on Photoshop, such as GIMP, which you can download from the GIMP website (www.gimp.org).

The free version of Photoshop Elements (version 12) comes with many built-in filters and special effects, and is great for beginners. However, you will have to pay if you want to add further filters, special effects, borders, frames, and other things. This trial version expires within one day, so you'll have to download and use the latest free version. You can use the trial version of Photoshop Elements for one month. During that time, you can use all Photoshop Elements features, including the ones in the paid version. After 30 days, if you have not purchased the full version, you'll need to pay Adobe \$0.00 to continue using the software. Note: Don't forget to close the
